

FORMAT REQUIRED FOR THE MANDATORY INFORMATION FOR EACH ATHLETE THAT REQUIRES AN ATHLETE LICENCE.

Once your Appendix 2 Bulk excel spreadsheet containing all your athletes that require a licence to be approved by WTF, you will from no earlier than **Monday February 14th** be able to log in through the ID number that WTF will provide your MNA via email and upload the **4 required documents** for each of your athletes. If you have trouble uploading online you can send to licence@wtf.org

Please read the below instructions carefully first before uploading online or emailing any documents to licence@wtf.org to ensure they are correctly formatted.

1. Colour Potrait ID picture with white background for Global Athlete Licence card

As the WTF Global Athlete Licence card will be used to verify athlete's at all WTF-promoted championships, the quality and size of the picture is **very important** and photos that do not meet the criteria below will be returned.

All photos to be uploaded to the system must adhere to the following guidelines:

1. The photograph must be a passport-style head shot of the member, suitable for use on the WTF Global Athlete Licence card. The photograph must be in colour with a white background.
2. The photo should be neatly cropped, not exceeding borders.
3. Photos should be 300 dpi. (This ensures the required quality for the licence card)
4. The image should be 2 cm by 2.5 cm (236x295 pixels).(**This ensures the correct size**)
5. The image file must be saved in an individual JPG format. Please do not put all the photos in one file.
6. The file name of each of the image files must correspond to the name of the athlete. For example, the image file for an athlete whose name is Beniot Forlan should be named Beniot_Forlan.jpg. This ensures that the correct photo goes on the correct athlete licence card.
7. The file size of each image file should not exceed 200 kilobytes.
8. **A sample of the correct and incorrect ID picture can be seen below as Appendix A.**

NB: To check whether your photos meet the above criteria or not, you can right click on the photo and go to properties to ensure the image is in the correct quality (300dpi) and size (236 x 295 pixels) as shown below in Appendix A.

If the ID picture is too big in size, the online system will automatically detect this and bring up a cropping tool which you can highlight the head and neck of the athlete and double click on the photo. The cropped image must include the full head of the athlete to be approved. The cropping tool will not be useful for images that are too small or not in good quality.

2. Completed and Signed PDF WTF Global Athlete Licence application form

1. The athlete licence application must be fully completed with required signatures in order for it to be accepted.
2. It is strongly recommend that each MNA types the required data within the PDF form itself to ensure accuracy of data. The form can then be printed and duly signed and stamped by the President or Secretary General of the respective member national association.
3. Each PDF document must be then saved individually either as a PDF document or JPG.
4. The name of the licence application document file must be saved as the name of the athlete.
5. **A sample of the completed licence application form can be seen below as Appendix 1.**

3. Passport with athletes photo page and signature

The following criteria must be met before uploading any passport copies for your athletes.

1. If scanning the passport, it should be cropped after it has been scanned so only the image you are uploading is the saved passport.
2. The passport image must be saved as an individual JPEG format or PDF document.
3. The name of the passport image file must be saved as the name of the passport holder.
4. The passport should be open as shown below with the photo page and the signature page and must be saved as one file.
5. **A sample of the Passport required can be seen below as Appendix B.**

4. Kukkiwon Dan/Poom certificate or card

The following criteria must be met before uploading any Kukkiwon Dan or Poom certificates/cards copies for your athletes.

1. If scanning the Kukkiwon Dan or Poom certificate/card, it should be cropped after it has been scanned so the only image you are saving is the Kukkiwon Dan or Poom certificate/card.
2. The Kukkiwon Dan or Poom certificate/card image must be saved as an individual JPEG format.
3. The name of the image file must be saved as the name of the Kukkiwon Dan or Poom certificate/card holder.
4. You can provide either the old or new Kukkiwon Dan certificate or the Kukkiwon Dan card. You only need to provide one of these formats.
5. **A sample of the 3 available options that can be received for the Kukkiwon Dan or Poom Certificate/card can be seen below as Appendix C1, 2 and 3.**

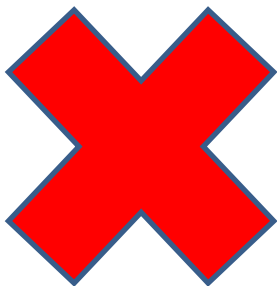

The application form must be signed by the athlete. All consent forms from minor applicants, according to the legislation of the applicant's country, must be counter-signed by their legal representative.

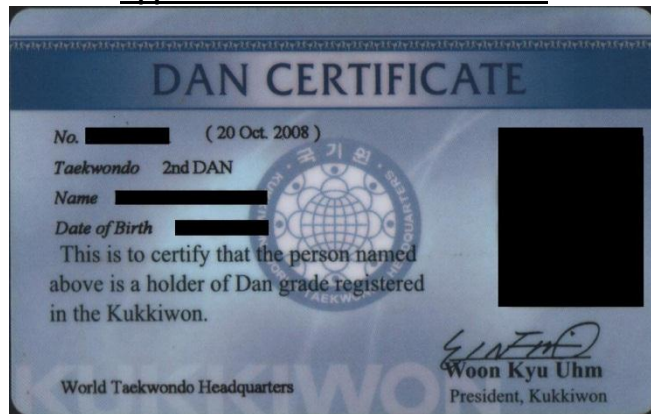

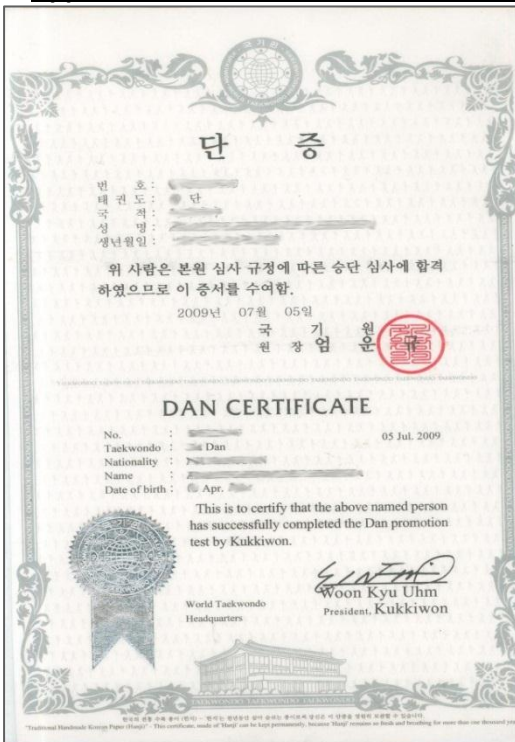


Appendix C - Sample Kukkiwon Dan Certificate or card required (only one required)
